# 6) Membership report

There are currently 109 members (58 adults, 3 under 16's, and 48 over 60's).

A discussion was held on the issue of **membership fees** which currently include a concessionary rate, a multiple year rate and a lifetime rate.

It was agreed that the membership be consulted on the following proposal:

- All adult membership (16 years and over) should be £10 per year.
- Junior membership (under 16) should be £5 –or £1 if the junior joins with an adult family member.

Following the consultation, there will be a proposal to change the membership fee structure which will then be voted on.

**Membership cards** need to be ordered-it was agreed to get some quotations for them.

**Recruitment of members:** it was agreed that a leaflet should be produced to publicise the work of the CST and distributed at forthcoming games. Grenville Hartley volunteered to produce one.

ACTION –Jue Vass to organise the consultation process on fees and to investigate prices for membership cards.

### 7) Updates

End of season awards-it was agreed to purchase the traditional clock as a permanent memento for the Supporters' Player of the Year Award recipient.

The Marie Curie Daffodil appeal had raised £4-it was decided to increase the donation to £20 from Trust funds.

The Living Waters Food Bank collection point at CFC was acknowledged as important yet had been only moderately supported so far. It was agreed that a "re-launch" of the appeal would be a good idea for the 2015-16 season.

Grenville Hartley had investigated the details of a special container.

The CST team entered in the *Asda Foundation Pennine Lancashire 10K* run in Burnley on 28/6/2015, currently has 5 runners. Paul Brennan had contacted Jamie Vermiglio to see if CFC players would be interested in supporting/joining the team.
